1. Present complaint has been filed by the complainant alleging that complainant's application for new connection has been rejected on the pretext of "installation of ELCB". Complainant, pleading that respondent has not released new electricity connection with the reason installation of ELCB, but complainant alleged that the said reason is absolutely wrong. Therefore he prayed this Forum for grant of his complaint by issuing directions to the respondent to allow release of new electricity connection.

2. The complainant in his complaint submitted that he applied for new electricity connection at premises no. GF, 21-A, Old no. 21/1, Gali No. 2, Guru Angad Nagar, Delhi-92, vide Request no. 8006055827 but respondent rejected his applications for new connection on the pretext of installation of ELCB. Therefore, complainant's application for release of new connection may be granted.

3. OP in its reply briefly submitted that the complainant applied for fresh electricity connection at premises no. GF, 21-A, Old no. 21/1, Gali No. 2, Guru Angad Nagar, Delhi-92, vide Request no. 8006055827. The complainant applied for new connection in respect of property which is parking area by making a shop therein.


OP further added that the premises have four floors and all the four floors have electricity connections. The total height of the building is more than 15 meters. The earlier connections were granted as the ground floor is taken as stilt parking area. As per norms one electricity connection bearing meter no. 55238833 already sanctioned for parking in the name of the complainant.


4. Case was put up for hearing on 25.04.2023, when representative of the complainant was present and submitted he wishes to withdraw his complaint.


5. In the facts and circumstances the withdrawal is allowed. Hence, the complaint is dismissed as withdrawn.

6. No order as to the cost. Both the parties should be informed accordingly.
