1. This complaint has been filed by Sh. Ghanshyam Singh, against BYPL-NNG.
2. The brief facts of the case giving rise to this grievance are that complainant Sh. Ghanshyam Singh is owner of property bearing plot no. 7, Khasra No. 17/5, Phase-II, Milan Garden, Mandoli, Delhi. Officials of respondent disconnected the electricity supply of the complainant except

other 28 connections and on same day respondent reconnected/restored supply of other consumers except the complainant. He approached respondent and moved an application vide order no. 1030583339 dated 16.07.2022 for restoration of supply and also attached DPCC certificate, MCD payment receipt and other relevant documents but respondent has not restored his electricity supply till date.


3. Respondent in its reply briefly stated that the complainant is seeking restoration of electricity connection bearing CA No. 150265566. It is further added that in terms of EDMC letter dated 22.06.2022 pertaining to re-sealing of factories/godowns at various divisions of respondent, two meters bearing no. 55364732 & 17146814 were removed and submitted to commercial office Nand Nagri BSES on 23.06.22. The bill of the complainant was finalized on 08.09.2022 by adjusting the security. As on date Rs. 18000/- is lying in credit of account of the complainant.

OP further added that complainant applied for restoration of electricity supply at subjected premises on 27.06.22 vide order no. 1030481497. The site of the complainant was visited on 27.09.22 and found locked. For restoration of electricity supply the complainant has to provide revocation order from MCD/DPCC and order from the competent authority regarding de-sealing of the premises.



During the course of arguments while hearing the case the counsel of the complainant disagrees with the OP's response, and complainant has placed on record an application praying to allow withdrawal of the complaint. Going through all the above facts and complainant's prayer, the withdrawal is allowed, hence, complaint is dismissed as withdrawn.
5. No order as to the cost. Both the parties should be informed accordingly.
