1. Present complaint has been filed by the complainant alleging that complainant's application for new connection has been rejected on the pretext of same site energy and enforcement dues. Complainant, pleading that respondent has wrongly concluded that there are pending dues of energy and enforcement, has prayed this Forum for grant of his complaint by issuing directions to the respondent to allow his applications for new connection.



2. The complainant in his complaint stated that he applied for new connection vide request no. 8005485858 at his premises no. 1789, FF, Gali Chuhanmal, Suiwalan, Daryaganj, Delhi-110002. He further submitted that respondent rejected his application for new connection on pretext of removal of existing meters, same site energy dues, same site enforcement dues and address in MCD objection list. Therefore, complainant's application for new connection may be granted.
3. OP in its reply briefly submitted that complainant is seeking fresh electricity connection at first floor of premises bearing no. 1789, Gali chunamal, Suiwalan, Delhi-110006 vide application no. 8005485858. The site was visited and it has been found that new connection cannot be granted for reasons as under:-
  - a) Outstanding dues against CA Nio. 100299326 in respect whereof amount is claimed on pro-rata basis of Rs. 1975/-.
  - b) Outstanding enforcement dues against CA No. 401566281, 401531298, 401377017, 401566280, 401461013, 401462213, 401535005, 401531297, 401495136, 401535003, 401561023, 401374093, 401461012, 401418094, 401496078, 401534000, 401561024, 401569149, 401531294 & 401479004.
  - c) Address exists in MCD objection list.
4. Case was put up for final arguments on 12.01.2023, when this Forum received an application dated 10.01.2023 moved by the counsel of the complainant that he wishes to withdraw his complaint.
5. In the facts and circumstances the withdrawal is allowed. Hence, complaint is dismissed as withdrawn.
6. No order as to the cost. Both the parties should be informed accordingly. File be consigned to Record Room.
