1. This complaint has been filed by Narender Kumar, against BYPL-LNR.
2. The brief facts of the case giving rise to this grievance are that complainant applied for new electricity connection vide request no. 8006163191 & 8006176896 at premises no. G-80, shop no. 4 & Shop no. 8, block G, Laxmi Nagar, Dehi-92 but respondent rejected the application of the complainant on pretext of address mismatch and other user dues pending.

3. OP in its reply briefly stated that the complainant is seeking new connections for two shops of property bearing no. 4 and 8 at G-80, Block - G, Laxmi Nagar, Delhi-92. At subject property outstanding dues are as under:-

- a) 100876237, Shop no. 2, G-80, Rs. 11381/-
- b) 100952211, G-80, Rs. 12040/-
- c) 100980773, G-80, Rs. 30920/-
- d) 101050698, G-80, Rs. 16480/-
- e) 151963036, G-80, Ground floor, Rs. 580/-
- f) 151987819, G-80, third floor, Rs. 3776/-

OP further added that beside outstanding dues there is mismatch of address in respect of applied address.

4. On the hearing dated 15.06.2023, counsel of the complainant submitted that his grievance has been redressed and submitted withdrawal letter to this effect.
5. From the above, it is clear that the grievance of the complainant is redressed upto his satisfaction.
