

- complainant is separated individual floor and he has no connection of other flats. Therefore he prayed this Forum for grant of his complaint by issuing directions to the respondent to allow his application for new connection.
2. The complainant in his complaint submitted that he applied for new electricity connection at premises no. D-123-B, Third Floor, West Vinod Nagar, Delhi-92 vide Request no. ONLNR2009220250 (8005920214) and ONLR211220089 (8006088895) but respondent rejected his application for new connection on the pretext of Removal of existing meter (35207226) is required in order to process new connection. Therefore, complainant's application for release of new connection may be granted.
 3. OP in its reply briefly submitted that the complainant applied for fresh electricity connection at premises no. D-123-B, Third Floor, West Vinod Nagar, Delhi-92 vide Request no. ONLNR2009220250 (8005920214) and ONLR211220089 (8006088895) and same was rejected an account of removal of existing meter *required sub*.
 4. Case was put up for hearing on 11.04.2023, when representative of the complainant was present and submitted withdrawal letter stating therein that he wishes to withdraw his complaint.
 5. In the facts and circumstances the withdrawal is allowed. Hence, the complaint is dismissed as withdrawn.
