1. This complaint has been filed by Sameer Siddiqui against BYPL-LNR. The brief facts of the case giving rise to this grievance are that Sameer Siddiqui applied for new electricity connection vide request no. 8006663189 at premises no. A-20, FF, J&K block, Laxmi Nagar, Delhi-110092 but respondent rejected his application for new connection on pretext of terrace locked, applied address and existing address different.

2. OP in its reply briefly stated that the complainant is seeking new electricity connection for the first floor of property bearing no. A-20, J&K block, Laxmi Nagar, Delhi-110092 for domestic category vide request no. 800663189. At the time of inspection it was found that the building structure consists of ground+four floors over it. It was also found that applied premises have outstanding dues amounting to Rs. 24192/- in the name of Darmesh Kumar at same address.
3. On the final hearing dated 23.01.2024, the counsel of the complainant agreed to make payment of the bill, provided if the complainant is allowed waiver off LPSC and instalments.
4. The prayer of the counsel of the complainant is accepted and OP is directed to waive off entire LPSC amount from the bill of the complainant and also allow the complainant to make balance payment in two equal monthly instalments. OP is further directed to release the new electricity connection to the complainant as applied by him after payment of the first instalment.

The case is disposed off as above.

No order as to the cost. Both the parties should be informed accordingly.
