1. Present complaint has been filed by the complainant alleging that complainant's application for new connection has been rejected on the pretext that his premises are booked by MCD. Complainant, pleading that respondent has wrongly concluded that his premises are booked by MCD, has prayed this Forum for grant of his complaint by issuing directions to the respondent to allow his application for new connection.

2. The complainant in his complaint submitted that he applied for new electricity connection at premises no. H.No. 12, GF, Satnam Road, Near Chachi Building Chowk, A1 block, Krishna Nagar, Delhi-51 vide application no. 8006157822 but respondent rejected his application for new connection on the pretext of address in MCD objection list, completion and occupancy certificate required. Therefore, complainant's application for release of new connection may be granted.
3. Case was put up for hearing on 10.03.2023, when counsel of the complainant vide his letter dated 10.03.2023 informed the Forum that he wishes to withdraw his complaint with permission to file afresh.
4. In the facts and circumstances the withdrawal is allowed. Hence, the complaint is dismissed as withdrawn.
5. No order as to the cost. Both the parties should be informed accordingly.
