

1. Present complaint has been filed by the complainant alleging that complainant's application for new connection has been rejected on the pretext of address mismatch and fire clearance required. Complainant, pleading that respondent has wrongly concluded that there is address mismatch and fire clearance required, has prayed this Forum for grant of his complaint by issuing directions to the respondent to allow his applications for new connection.

2. The complainant in his complaint submitted that he applied for new electricity connection at premises no. B-20 & B-21-B, 126/10, B-block, Gurunanak Pura, Laxmi Nagar, Delhi, vide application no. 8006067538, 8006067582, 8006067613, 8006067622, 8006067528 and 8006067570 but respondent rejected his application for new connections on the pretext of premises appearing in MCD objection list. Therefore, complainant's application for release of new connection may be granted.
3. Case was put up for hearing on 23.02.2023, when representative of the complainant submitted withdrawal letter stating therein that wishes to withdraw their complaint.
4. In the facts and circumstances the withdrawal is allowed. Hence, the complaint is dismissed as withdrawn.
5. No order as to the cost. Both the parties should be informed accordingly. File be consigned to Record Room.
