1. The brief fact of the case giving rise to this grievance is that the complainant applied for new electricity connection vide request no. 8007105646 at premises no. J-3/14-15, Common Stairs, J-extension, Laxmi Nagar, Delhi-110092 which was rejected by OP on grounds of common connection not feasible.

2. The respondent in reply briefly stated that the present complaint has been filed by the complainant seeking single new DX connection for common stairs which is declined on the pretext of common connection is not feasible since common load is not separately metered.
3. Counsel for the complainant in its rejoinder refuted the contentions of the respondent as averred in their reply and submitted that staircase is having separate common load and the complainant has submitted the NOC from the other owners/registered consumers of the existing connections residing in the applied premises.
4. Heard arguments of both the parties at length.
5. Since the complainant has fulfilled the requirement of the OP by filing NOC of the other owners/registered consumers of the applied building, thus no objection of OP remains pending for release of the new connection to the complainant. Therefore, OP should release the new electricity connection as applied for by the complainant.

ORDER

The complaint is allowed. OP is directed to release the new electricity to the complainant as applied for by the complainant vide application no. 8007105646 at common area of premises no. J-3/14-15, common stairs, J-extension, Laxmi Nagar, Delhi-110092 after completion of other commercial formalities as per DERC Regulations 2017.

This Order shall be complied within 21 days of the receipt of the certified copy or from the date it is uploaded on the Website of the Forum; whichever is earlier.


The parties are hereby informed that instant order is appealable by the Consumer before the Ombudsman within 30 days of the receipt of the Order.
