1. Present complaint has been filed by the complainant alleging that complainant's application for bill revision has not been considered by OP. Complainant, pleading by issuing directions to the respondent for revision of his electricity bill.

2. The complainant in his complaint submitted that he is owner of property no. 202/15, Idgah Road, Motia Khan, Paharganj, New Delhi-110055 and using electricity through CA no. 152364663. It is also his submission that OP transferred dues of disconnected CA No. 100528037 amounting to Rs. 1,56,183/- to his live connection. The said disconnected meter was installed at premise no. 11119-A, Motia Khan, Delhi-110055 and nowhere pertains to him. Therefore, complainant's application for withdrawal of transferred dues may be granted.
3. Case was put up for hearing on 24.01.2023, when OP submitted withdrawal letter from counsel of the complainant submitting therein that the dues amounting to Rs. 1,56,183/- were transferred to his live connection has now been settled for Rs. 75,200/- after waiver of LPSC by the OP. His grievance stands redressed therefore, he wishes to withdraw his case.
4. In the facts and circumstances the withdrawal is allowed. Hence; complaint is dismissed as withdrawn.
5. No order as to the cost. Both the parties should be informed accordingly.
