1. Present review under Regulation 19 of DERC (Forum for Redressal of Grievances of the Consumers and Ombudsman) REGULATIONS, 2018 has been filed by OP against order passed by this Forum, in CG no. 268/2024 dated 07.03.2025. Ground for review OP states that there is an error apparent on the face of the record. As per Para 3 of the review application ".....

The applicant would like to place on record the recent guidelines issued by the Hon'ble High Court in W.P. (c) 7736/2023 titled as BSES YAMUNA POWER LIMITED VS GYANENDER & ANR, wherein the Hon'ble High Court was seized off the issue pertaining to the release of new electricity meter when the applied area falls under the dispute of Jurisdiction of Delhi or UP while adjudicating appear preferred against the order passed by Ld. CGRF in CG No. 176/2022.


Because the Hon'ble High Court of Delhi was pleased to issue certain directions to be followed when the nature of dispute viz a viz Delhi or UP arises. The relevant extract is being reproduced below:

12." Considering the nature of the dispute before this court, it is directed that before passing any orders in similar cases, learned CGRF shall obtain reports from the Revenue Department, GNCTD, in order to assess the fact as regards the location of the said premises, and whether the same fall within the jurisdiction of such electricity supplying companies, or not."

In the instant case, no records from the Revenue department or report from the concerned SDM were taken on record to assess the jurisdiction in which the applied premises are correctly and truly situated.


2. As per para 3.7 the order under review got passed due to inadvertent error and concealment on the part of the complainant herein which would not have been passed had it been the complainant would have not concealed this fact from this Hon'ble Forum and stated about the police complaint against the applied premises.
3. The order of the Forum in the matter of Mohan Lal Vs BSES YPL was dated 07.03.2025 and Hon'ble High Court's order in the matter of BSES YPL VS GYANENDER & Anr. is dated 24.03.2025


