1. The brief facts of the grievance are that the complainant applied for revocation of Name change against Meter having CA no. 154490086 installed at premises no. 2797, 3rd Floor, Gali Gadhiya, Daryaganj, Delhi-110002.

The complainant also submitted that the said connection was energized in his name in the year 2021 later on same was changed to the name of Mohd Saeed without informing the complainant. Now the complainant wants to revert the name change in favour.

2. The respondent in its reply against the complaint of the complainant submitted that the complainant is seeking name change of the electricity connection bearing CA No. 153537186 which was earlier registered in the name of complainant and now the name of R.C has been changed of the electricity connection installed at premises no. 2797, 3rd Floor, Gali Gadhiya, Daryaganj, Delhi-110002.

Reply further submitted that Mohd Saeed had applied online for name change for R.C of electricity connection bearing C.A No. 153537186 and submitted Copy of Aadhar Card, Copy of GPA dated 20.10.2021 by Haris Khan in favour of Mohd. Suhail, Copy of GPA dated 10.12.2022 executed by Mohd Suhail in favour of Mohd Saeed.

That having proceeded, the respondent has changed the name of R.C to Mohd Saeed.

It is further submitted that the complainant has not impleaded Mohd Saeed in the present complaint while Mohd Saeed being the necessary party must have been impleaded U/o 1, Rule 9 C.P.C. That in para No.1 of the present complaint, the complainant has mentioned that he lives along with his family on the premises 2797, 3rd Floor, GaliGadhiya, Daryaganj, Delhi-110002 before 2020.

3. The complainant did not file rejoinder.

4. Arguments of both the parties were heard.

5. Mohd Saeed was impleaded as party in the present case. On final date of hearing Mohd Saeed and Mohd Suhail both were present before the Forum. Mohd Saeed stated that he has no objection in reverting the name change in favour of Mohd Suhail.

6. Since both the parties "Mohd Suhail & Mohd Saeed" agreed to the restoration of name of electricity meter from Mohd Saeed to Mohd Suhail, we do not find any hurdle to process the application for Restoration of Name in favour of Mohd Suhail. Both the parties also submitted an affidavit to this effect.


ORDER


The complaint is allowed. OP is directed to revert the name of electricity connection as applied for by the complainant vide CA no. 154490086 installed at premises no. 2797, 3rd Floor, Gali Gadhiya, Daryaganj, Delhi-110002 after completion of other commercial formalities as per DERC Regulations 2017.

OP is further directed to file compliance report within 21 days of the action taken on this order.

If the Order is not appealed against within the stipulated time, the same shall be deemed to have attained finally.

Any contravention of these Orders is punishable under Section 142 of the Electricity Act 2003.
