1. Present complaint has been filed by the complainant alleging that complainant's application for new connection has been rejected on the pretext of premises under MCD objection list. Complainant, pleading that respondent has wrongly concluded that the premises of the complainant is booked by MCD, has prayed this Forum for grant of his complaint by issuing directions to the respondent to allow his applications for new connection.



2. The complainant in his complaint stated that he is residing at property no. F-153-A-1G, Upper First Floor, left side, Kh. No. 57/1, Ramesh Park, J.P. West, Laxmi Nagar, Delhi. It is also his complaint that he applied for new electricity connection vide request no. 8005787080 but respondent rejected his application for new connection on the pretext of premises under MCD objection list. Therefore, complainant's application for new connection may be granted.
3. OP in its reply briefly submitted that complainant is seeking fresh electricity connection at upper first floor of property bearing no. F-153-A-1F, Upper first floor, left side, Khasra no. 57/1, Ramesh Park, J.P. West, Laxmi Nagar, Delhi vide application no. 8005787080 which was initially rejected as applied address was found in MCD objection list, later complainant deposited BCC but the new connection could not be released as on site visit complainant though he applied for upper first floor showed the first floor of the building and sought fresh electricity connection in respect of first floor. However, first floor already had two electricity connections as such no new electricity connection is possible.
4. Case was put up for final arguments on 12.01.2023, when this Forum received an application moved by the complainant that he wishes to withdraw his complaint.
5. In the facts and circumstances the withdrawal is allowed. Hence, complaint is dismissed as withdrawn.
6. No order as to the cost. Both the parties should be informed accordingly.
