Present complaint was filed by the complainants for release of new electricity connections as applied by them vide request no. 8006709581, 8006709574 and 8006709578 at premises no. B-266, Gali No. 12, Bhajanpura, Delhi-110053.

OP in its reply submitted that they have rejected the applications of the complainants for new connections on grounds that building is booked by MCD vide letter no. EDMC/EE(B)-II/SH-N/2018/D-51 dated 09.03.2018. OP also stated that before these applications, they have received two more applications having no. 8006518014 and 8006518007 with address B-267, Gali No. 12, Bhajanpura, Delhi-110053 and as per record house no. B-267 is already booked.

During the course of arguments, it was pointed out that the complainant Nikita is having Aadhar card with name Nitika Sharma, the counsel of the complainant was asked to verify the same. The counsel of the complainant withdraw the application Nikita/Nitika vide request no. 8006709581 for second floor of the said building as not pressed.

Thereafter, for the connections of Lokesh Sharma for ground floor and first floor, property documents were scrutinized. Two different GPA's were placed on record one by the complainant himself and other by OP.

The GPA filed by the complainant is of 19.12.2020 in favour of complainant Mr. Lokesh Sharma by Ms. Shumaila for property no B-266 area measuring 50 sq yards. GPA further shows that on the east, west and south of this property there are portion of others property and on the north there is 15 feet wide road.

  



The previous chain of this property was filed by the complainant which is of December 1999 executed by Sh. P.K. Jain in favour of Ms. Sumaila for property bearing no. B-266. The east side of this property shows remaining portion, north and south shows property of others and the west side shows gali.

It is clearly evident that there is discrepancy in both the GPA's of same property i.e. property no B-266. Undoubtedly it is case of forged documents.

When this anomaly pointed out, the counsel of the complainant after initially ~~requested~~ resisted but ultimately requested for permission to withdraw.

We express our displeasure that complainant tried to mislead this Forum.

Therefore, this complaint is dismissed as withdrawn.
