1. This complaint has been filed by Mr. Rajan Kumar Pasan against BYPL-KRN.
2. The brief facts of the case giving rise to this grievance are that complainant Mr. Rajan Kumar Pasan is registered consumer of CA No.

150822563 since 2013 which is installed at premises number F-17/14, Krishna Nagar, Delhi-110051 and wanted to disconnect the supply of this connection. It is also his submission that this property is parental property and he is having symbolic possession in small portion in the property whereas his brother Sh. Deepak Prakash Pasan is under the possession of rest of the property. He further added that there is a property dispute between him, his brother and 4 other share holders being the legal heirs of his father Lt. Sh. Sardar Lal and matter is pending before Hon'ble High Court of Delhi and the status qua to the title of the property has been passed by the Hon'ble Court of Delhi just restraining his brother from illegally disposing the property.

3. The respondent in reply briefly stated that that complainant is registered consumer of CA no. 150822563 filed present complaint for disconnection of said electricity connection by removing the meter installed at Old Anarkali, Krishna Nagar, Delhi-51 on 19.10.2022. On request of the complainant the premise of the complainant was visited on 19.10.2022 and 12.12.2022 for disconnection of supply and removal of meter, however, due to resistance at site disconnection of supply and removal of meter could not take place. The person available at site who objected to disconnection stated that there is a court case pending between him and the complainant but failed to produce any court order.
4. Case was put up for final arguments on 12.01.2023, when Forum received an application moved by the complainant stating therein that he wishes to withdraw his complaint. Since the complainant himself has prayed for directions to allow him to withdraw his complaint.

5. In the facts and circumstances the withdrawal is allowed. Hence, complaint is dismissed as withdrawn.
6. No order as to the cost. Both the parties should be informed accordingly.
