1. This complaint has been filed by Mr. Ramesh Balooni against BYPL-LNR.
2. The brief facts of the case giving rise to this grievance are that complainant Mr. Ramesh Balooni applied for new connections vide

request no. 8005988347, 8005988252, 8005988217, 8005988258 at premises no. H.No. 15, Garhwali Mohalla, LAXMI Nagar, Delhi-92 but respondent rejected his application for new connection on pretext of MCD objection. Therefore, complainant's application for release of new connection may be granted.

3. OP in its reply briefly stated that complainant applied for new electricity connections vide request no. 8005988347, 8005988252, 8005988258 and 8005988217 at premises no. H.No. 15m, Garhwali Mohalla, Laxmi Nagar, Delhi-110092. The said premises are divided into three portions of Ms. Suman Baluni w/o Sh. Devendra Prasad Baluni, Ramesh Baluni and Bhaskar Baluni. Devendra Prasad Baluni, Ramesh Baluni and Bhaskar Baluni are brothers. The application premises wise is as under:
 - i) 8005988252 (GF), the said application was moved by Mayank Baluni s/o Devendra Prasad Baluni. As meter no. 55296724 already exists at ground floor as such the said application was rejected.
8005988258 (TF), the said application was accepted and connection stands energized.
 - ii) In respect of premises of Ramesh Baluni, the building structure is ground plus four floors, the fifth floor is under construction. 8005988217, 4th floor, the said application was moved by Ramesh Baluni, the said application is rejected due to the reasons that building height is more than 15 meters as such architect certificate is required for electrification of fourth floor which is effective fifth floor. In the building already six meters exists. Two meters are without any floors.
 - iii) In respect of premises of Sh. Bhaskar Baluni, the building structure is Ground plus four.

8005988347, the said application was moved by Madan Lal Batra on the basis of sale deed in respect of first floor of the property purchased from Vijaya Baluni w/o Bhaskar Dutt Baluni. As meter nos. 11224327 and 55363607 already exists without any floor mentioned.

The applicant is advised to get the one of the connections without floor mentioned on it transferred in his name with rectification of billing address by getting floor mentioned in it.


4. Arguments of both the parties are heard.
5. During the course of arguments OP stated that they would resolve the matter and asked the representative of the complainant to approach the division office. The representative of the complainant submitted that he would do so and wishes to withdraw his complaint.

Thus, the grievance of the complainant stands redressed.

The case is disposed off as above.

No order as to the cost. Both the parties should be informed accordingly.
