1. Present complaint has been filed by the complainant alleging that complainant's application for new connection has been rejected on the pretext of MCD booking. Complainant, pleading that respondent has wrongly concluded that


there is no MCD booking, has prayed this Forum for grant of his complaint by issuing directions to the respondent to allow his applications for new connection.

2. The complainant in his complaint submitted that he applied for new electricity connection at premises no. SF, Kh. No. 256, 12A/159, Gali no. 13, Vijay Mohalla, Maujpur, Delhi-110053 vide application no. 8005964290 but respondent rejected his application for new connection on the pretext of applied premises booked by MCD. Therefore, complainant's application for release of new connection may be granted.
3. OP in its reply briefly stated that complainant applied for new electricity connection vide application no 8005964290 at second floor of Kh. No. 256, 12A/159, Gali no. 13, Vijay Mohalla, Maujpur, Delhi-110053. OP further added that application for new connection of complainant was rejected as applied address was found in MCD objection list at serial no 19 and as per the objection list circulated by MCD unauthorized construction is in the shape of GF, FF, SF, TF & FF. Besides this at the time of site visit it was found that building which consists of ground plus four floors has two dwelling units on second floor and both the units are electrified.
4. Case was put up for hearing on 16.02.2023, 28.02.2023 and 21.03.2023, when on all the three consecutive hearings none was present on behalf of the complainant. The complaint of the complainant was dismissed.

5. In the facts and circumstances it seems that complainant is no longer interested in pursuing his matter in the Forum. Accordingly, the present complaint is disposed off as dismissed in default.
6. No order as to the cost. Both the parties should be informed accordingly.
