Both the parties admitted that the meter has been installed.

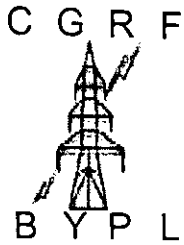



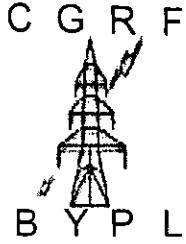
