Briefly stated facts of this case are that the complainant sought withdrawal of illegal dues transferred by the respondent to his CA No. 152045768.

It is his submission that he purchased property no. A-8, Khasra No. 898/190, Gali No. 1, Jagat Puri Extension, Delhi from Sh. Sumit Kumar S/o Sh. Sunil Kumar and Smt. Sadhna on 28.08.2018, where already a connection was installed with meter no. 35247737 and CA No. 152045768. He further states that at the time of purchasing the property there were dues amounting to Rs. 72210/-, which he cleared after waiver of LPSC by the respondent.

Complaint No. 64/2019

The complainant states that in March 2019 the respondent added an amount Rs. 71,844.85/- in his electricity bill and on enquiry the respondent stated that they have transferred the bill amount of Smt. Sadhna having CA No. 101547089, which was installed in the same premises.

It was also his submission that Smt. Sadhna is residing at C-3/202, Nand Nagri, Delhi-93 and a meter is also installed at the same premises vide CA No. 151696497 and the respondent company should recover the said dues from her. Therefore, he has prayed the Forum to transfer the disputed amount of Rs. 71,884.85/- to CA No. of Smt. Sadhna.

Notice was issued to both the parties to appear before the Forum on 30.10.19.

The respondent company submitted their reply stating therein that an electricity connection vide CA No. 101547089 was installed on 08.10.2002 at premises no. A-8, Khasra No. 898/190, Gali No. 1, Jagat Puri Extension, Delhi-93, in the name of Smt. Sadhna Devi which was disconnected on 21.08.2007 due to non-payment of dues.

A site visit was conducted on 28.12.2018 and it was found that the premises in issue where the disconnected connection i.e. connection bearing CA NO. 101547089 was now providing electricity through live connection registered in the name of Mr. Sumit Kumar bearing CA No. 152045768.

Accordingly, the registered consumer of the live connection was served with notice dated 14.01.2019 in terms of Delhi Electricity Supply code and Performance Standards Regulations 2017 whereby the consumer was issued a personal hearing on 28.01.19. However, inspite of receipt of the notice none approached the respondent.

Complaint No. 64/2019

Further, the complainant also settled a direct theft bill of Rs. 17,500/- in lieu of full and final settlement of bill of Rs. 106959/- in Permanent Lok Adalat on 25.09.2019, pertaining to the same disconnected connections i.e. CA No. 101547089.

It is pertinent to mention here that the Forum directed that the erstwhile owners of the property namely Sh. Sunil and Smt. Sadhna be also present for better understanding of the case. Notices were also sent to the erstwhile owners of the property but they did not appear before the Forum. Respondent was also directed to submit their written submissions on the next date of hearing.

Further, during the pendency of this case, both the parties were also directed by this Forum to try for amicable settlement in this particular complaint.

The complainant has filed a letter duly signed by him stating that his grievance is satisfactorily addressed and he wishes to withdraw his complaint.


Since the complainant had moved an application requesting for withdrawal of the complaint, we find it prudent to dispose of this case as withdrawn.
