All these connections were given on the basis of GPA dated 10.07.2001, where details of the plot land measuring 88 sq. yards was given and neither floor nor any other details were given.

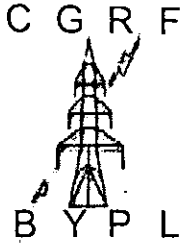
The complainant produced a registered sale deed dated 03.09.2024 in which Pooja Goyal has been shown as purchasing built in entire first floor. The complainant is claiming that the meter used at first floor is being used for second floor.

In view of all these documents and situation there appears a total chaos with regard to electricity connections and floors. The OP is advised to completely review all the connections at all floors and to disconnect the connections which are not properly matching with the floors. Thereafter, the property owners may apply for fresh electricity connections giving the exact floors with matching property documents.

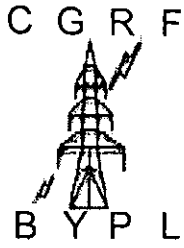




