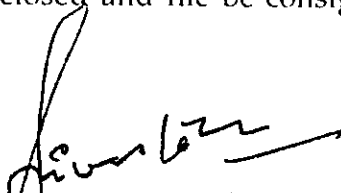
During the course of arguments, OP stated that if the complainant applies a fresh for new electricity connection along with submissions all the documents they would process the application of the complainant for new connection.
